### Approved Budget

This budget will raise more revenue from property taxes than last year's budget by an amount of \$667,403, which is a 4.44 percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$263,158.09.




**This year's levy to fund maintenance and operations expenditures exceeds last year's maintenance and operations tax levy.**
